

His Excellency The Grand Master Don Basilio di San Lorenzo, Sovereign Order of St. John Of Jerusalem, Knights of Malta,

INTENDING to strengthen the bonds of friendship, Co-Operation & Mutual Assistance between the "Academy Of Universal Global Peace" & The "Sovereign Order of St. John of Jerusalem, Knights of Malta", and DESIRING to enhance the prosperity of those two contractors and intensity their mutual relations in accordance with the principles of the two contractors Laws, have resolved to conclude a Treaty on Friendly Relations, Co-operation & Mutual Assistance, who having exchanged their full powers found to be in good and due form have agree upon the following articles:

#### Article 1

The "Academy Of Universal Global Peace" & The "Sovereign Order of St. John of Jerusalem, Knights of Malta", declare that they will further maintain The peaceful and friendly relations between these two contractors and Organizations world wide

#### **Article 2**

The subjects of either High Contracting Party shall have in the territory of the other protection for their persons and property in accordance with the Laws of the High Contracting Party concerned.

#### Article 3

Subjects in relation to the Academy Of Universal Global Peace and Subjects in relation to The Sovereign Order of St. John of Jerusalem, Knights of Malta, shall be categories of persons determined by the House Laws and respective the both contractors.

#### **Article 4**

The two High Contracting Parties shall, with a view to furthering human, cultural and economic relations Endeavour to develop to the best of their ability the possibilities of mutual information in order that they may deepen their knowledge of each other and intensity their relations in general.

#### Article 5

The "Academy Of Universal Global Peace" & The "Sovereign Order of St. John of Jerusalem, Knights of Malta" acting in accordance with the spirit and purpose of the present Treaty a fruitful co-operation between all countries and supplement such co-operation by means of bilateral measures to accomplish the Common aims of facilitating cooperation in Charity, Relief, Rehabilitation & Humanitarian works for the Victims in the Natural Disaster affected areas, International law, International security, Sustainable development, social, human rights, achievement of Global peace, Youth- Women- Children Empowerment, Poverty Alleviation, Education, Health, Sanitation, in the area of Science, Technology & Environment, Global emerging issues like global warming, HIV AIDS, Food Security, etc.

#### Article 6


The High Contracting Parties shall as soon as possible begin negotiations on the conclusion of a skeleton agreement to facilitate technical co-operation. They shall embark to technical co-operation between the two contractors in each fields and on such term as are laid down in special arrangements and are of practical value and importance.

#### Article 7

This Treaty shall be ratified by the mutual consent of both the Contracting Parties. The instruments of ratification shall be exchanged as soon as possible.
