The International Human Rights Commission was founded by the seven organizations in their leader conference held at London on 10th of December 1988 to create the international network of human rights. The International Human Rights Commission have its diplomatic / Official representation in 42 Countries and more than 7500 members around the world and connected through the Face Book/ electronic mail, till March 2012, More than 2250 NGO's from different countries linked and got membership of the Commission.

The Commission also providing its services to the United Nations, European Union, Organization of Islamic Conference, and their member states according to the "**UNIVERSAL DECLARATION OF HUMAN RIGHTS**" passed by United Nations on 10th of December, 1948 and playing role to develop the culture of peace, religious and political tolerance around the world and also representing the Indigenous people & Nation for their rights.

The IHRC & OIC Secretary General also signed the request to establish the Formal relations between IHRC & OIC in the leaders' summit held at OIC Secretariat at Jeddah on 23rd June, 2012 as Intergovernmental Organizations.

The IHRC also entered in reorganization with the EU through Transparency Registrar of European Commission. The IHRC also enjoying the bilateral relationship with the Republic of Lebanon, Arab Republic of Syria, State of Kashmir (Pakistan) and still in negotiation to develop relationship with many other countries.
